#### X. REPORT OF DISTRICT EMPLOYEES

- a. District Secretary
  - i. Women's ag night is coming along. Picked up the material for the ag department at the school to make projects for door prize giveaways. Have a \$1,000 grant and have only used about \$300 of it. The grant can be used for the speaker fees also. the board suggested extending an invitation to the teacher and 5 of her students to attend our women's ag night and hand out the prizes.
  - ii. As of now we have \$1500 in newsletter sponsors.
  - iii. Newsletter question changed it from a question to anyone that filled out what we can do to improve would be entered and we have not gotten one response. So would like to try it again next month. Board suggested maybe not only answering by email but maybe text too.

## b. District Technician

- i. ARS would like us to do a hand plant project for them this year. It would be to replace the trees that did not survive the planting from last year. We would need to get an earth auger to drill the holes as there are about 250 plus trees to plant. We would be able to rent out the earth auger if we decide this is not something we want to get into. The board had lots of discussion on this and think it would be a good idea to run a trial hand plant with the ARS to see if this is something we would want to get into. The board asked for more information on this process such as price of earth augers and cost to plant the trees and bring it to the next meeting.
- ii. As a new employee, will need to take the level 1 training but will not be able to take it in March so looking to find alternative dates.

iii. Wondering about hiring an intern again this year. The board feels like it is a good idea to hire someone if we have good applicants. Also wondering if the crew from last year will be coming back. The board suggested to reach out to the past crew to see if they will be returning.
